II. Course Objectives:

Students should develop:

- A. A grasp of the nature, methods, and basic issues involved in biblical interpretation.
- B. Skill in interpreting different genres of Scripture.
- C. Growing expertise in dealing with exegetical and hermeneutical challenges.

III. Course Texts:

IV. Course Requirements:

- A. Readings (10%): The respective chapter in Köstenberger & Patterson is to be read prior to the class where a given topic is covered or at least prior to the next class period. Students are to keep track of their own readings and certify the completion of all reading requirements on the last day of class.
- B. Quizzes (30%): Class periods will normally begin with a short quiz on the material covered during the last class period. The worst quiz may be dropped. No make-up quizzes. Students are to keep track of their own readings and certify the completion of all reading requirements on the last day of class.
- C. Teaching Outlines 1 and 2 (30% each, 60% total): Students are to prepare two teaching outlines/presentations, one on a passage from the OT and the other on a NT passage, from a selected list distributed in class. Research notes are to be attached to the submitted assignment. Detailed instructions will be given in class.
